I am directed to say that in terms, of Rule 14 of the rules for the regulation of recruitment to the Clerical Services of the Secretariat and certain other offices of the Government of West Bengal as amended by the Finance (Audit) Department Notification No. 3943-F dated the 16th August, 1982 and No. 9045-F dated the 26th July 1983 the next Half-yearly Departmental Examination in Bengali for probationary Lower Division Assistants recruited through the Clerkship Examination and whose mother tongue is not Bengali, will be held on the 11th December, 2008 in the Examination Hall of the Commission at 161-A, S. P. Mukhererjee Road, Kolkata - 700 026.

The examination will be held in two parts viz. Part-I (Written) and Part-II (Oral). Candidates passing in one part shall not be required to appear in the same part again. Details relating to the two parts of the examination are given in a Statement enclosed (Enclo.-I).

I am, accordingly, to request you to be so good as to issue a circular to the Departments and offices concerned requesting them to forward to the Commission direct the names and particulars of the L.D. Assistants, whose mother tongue is not Bengali and who are eligible and willing to appear at the ensuing Departmental Examination. The cases may be forwarded to this office in the enclosed proforma (Enclo.-II) on or before the 29th October, 2008. It may be noted that names received thereafter will not be entertained by the Commission for the examination. The time-table of the examination will be communicated to the candidates through their Departments/Offices in due course.
