A question has been raised from different quarters as to the budget-head against which the expenditure towards reimbursement of the benefit of L.T.C. will be debited and in what manner the claims for such reimbursement will be preferred.

2. After careful consideration of the matter the undersigned is directed to say that in partial modification of this Department Memo. No. 9924-F dt. 7.12.2005 read with Memo. No. 607- F dt. 20.01.06 the following procedures may be adopted for disposal of the claims for the benefit of L.T.C.:-

- (a) The expenditure of L.T.C. will be debited under the sub-detailed head "07- Other Allowance" under detailed head "01-Salaries" under all concerned major and minor heads under concerned Demands.
- (b) The claims for L.T.C. should be preferred in T.R. Form No. 22 of W.B.T.R.- 05.

(c) While submitting claims for the L.T.C., if possible original tickets may be submitted to the Controlling Authority for verification. In the absence of original tickets, the photocopies of the tickets will have to be produced.
