State Government Departments / Directorates / Offices are directed not to nominate any organization other than those listed above for execution of Government works as agency of the Government.

This order will come into effect immediately. However, Contract / MOU which has already been executed with any PSU which was earlier included in the Annexure C but now not considered in the present list need not be revised.
