***Sub : The All India Services (PAR) Rules 2007- Annual Medical Check up for IAS Officers.***

Sir,

I am directed to state that as per the All India Services (PAR) Rules 2007, annual Medical check up has become mandatory for the IAS Officers above the age of 40 years and may be totally dispensed with for Officers below the age of 40 years except in case of Medical incident. Accordingly, a PROFORMA for health check up for IAS Officers has been prescribed in from IV of the said Rules.

The Central Government has finalized the Modalities for the Health check up in respect of the IAS Officers serving under the Government of India. They have now requested the State Government to work out appropriate arrangements and authorize Government and private Hospitals in the State for the health check up of IAS Offices working under the State Government so that an Officer can get the health check up done without any reference from the authorized Medical Attendants and the Officers do not face any inconvenience.

The issue relating to annual Health check up for IAS Officers has been examined in consultation with the Health & Family Welfare Department and the Finance Department. The Health & Family Welfare Department has selected 9 (nine) Medical College & Hospitals and 15 (fifteen) District Hospitals as per enclosed list (List-I) where all these investigations/tests can be carried out for this purpose.

The Health & Family Welfare Department has also provided a list of 8 (eight) private Hospitals/ Diagnostic Centres as per enclosed list (List-II) which have agreed to conduct all the tests as prescribed in the Health check up PROFORMA for Rs. 1,900/- per officer which is reimbursable consequent upon preferring claim for reimbursement by the concerned IAS Officers if they visit such approved private Hospitals/Diagnostic Centres for Medical Check-up. The Health & Family Welfare Department and the Finance Department have agreed to reimburse a sum of Rs. 1900/- (Rupees one thousand nine hundred) for such Medical Check-up if done all above mentioned approved Diagnostic Centres/Private Hospitals.

In the circumstances, I am directed by order of the Governor to say that the Governor is pleased to authorize all Heads of the Departments to reimburse the cost of above medical tests upto the limit of Rs. 1,900/- in each case.

This issues with the recommendation of the Health & Family Welfare Department and with the concurrence of the Finance Department vide their U.O. No. 1162-Group 'P' Services dated 28.03.2008.
