***Sub: Grant of D.A./A.D.A. to the employees of the various Non-Govt. Organizations controlled by Social Education Branch of Higher Education Department, Govt. of West Bengal.***

In continuation of G.O. No. 130-Edn(H/SE) dt. 10.12.2008, the undersigned is directed by order of the Governor to say that the Governor has been pleased to direct that in terms of Finance (Audit) Department's Memo No. 1370-F dt. 12.02.2009 all whole-time approved teaching and non-teaching employees of the (i) *Institute of Development Studies, Kolkata (IDSK)*, (ii) *Bankim Bhavann Gavashana Kendra*, (iii) *Institute of Historical Studies*, (iv) *Jagadish Bose National Science Talent Search (JBNSTS)*, (v) *Assembly Hall-cum-Auditorium, Central Office & Commercial Institute Of R.K.M. Ashrama, Narendrapur*, (vi) *Central Office Of R.K.M. Ashrama, Baranagar*, (vii) *Central office of R.K.M. Vidyapith, Purulia*, (viii) *Netaji Institute for Asian Studies (NIAS)* and (ix) *Paschim Bangal Hindi Academy*, shall draw Dearness Allowances at the following rate under usual terms and conditions as laid down in the G.O. mentioned above:

<b>Period from which payable</b>	<b>Pay Range</b>	<b>Rate of D.A. per month</b>
01.03.2009	Pay upto Rs.26,000/-	47% of Pay per month

2. The calculation of D.A. would be made taking into account the basic pay drawn in the prescribed scale of pay and Dearness Pay as introduced in G.O. 130- Edn(H/SE) dt. 10.12.2008.
3. The D.A. admissible in terms of para-1 above shall be rounded off to the nearest rupee in each case.
4. The Governor has further been pleased to decide that the daily rated worker under the Govt. whose wages are not regulated by any statutory provisions like Minimum Wages Act etc. there will be a further ad-hoc increase in their existing daily rate of wages by Rs.7/- (Rupees Seven) only with effect from 01.03.2009.
5. The charges involved will be debited to the respective appropriate heads in the current year's Non-Plan Budget under the head, "2202-General Education"/ 2205-Art and Culture".
6. All concerned are being informed.
