**MEMORANDUM**

The question of revision of scale (s) of pay of some of the posts under different Departments has been under active consideration of the Government for some time past.

3. The revised pay scale(s) shall take effect from 01.01.96 notionally and actual effect will be given from 01.01.2008.
4. The Officers holding the posts mentioned here may exercise fresh option under W.B.S. (ROPA) Rules, 1998 within 90 days' from the date of issue of this order.
5. The rules of initial fixation of pay in the revised pay scale(s) and all other conditions laid down in the W.B.S.(ROPA) Rules, 1998 excepting the date of actual effect shall apply mutatis – mutandis.
