## Sub: West Bengal State Govt. Employees Group Insurance Scheme, 1987- Table of benefit under the Savings Fund.

In continuation of this Deptt. Memo No. 11706-F dt. 30.12.99 undersinged is directed to say that another Table of benefit showing the accumulation in the savings Fund of the above mentioned scheme corresponding to an unit subscription of Rs. 10/- p.m. have been drawn up for the year 2000-2001. A copy of the said table is enclosed herewith for guidance. In the calculation, interest has been allowed ab-initio @ 12\% per annum (compounded quarterly, as usual.
2. The amount shown in the table is payable to a member of the scheme belonging to Gr. 'D' on cessation of service. Corresponding amount payable to members of higher groups shall be worked out proportionately.
3. It is assumed that full subscription has duly been realised from the salary for the month in which a member ceases to be in service, failing which the same shall be deducted from his entitlements.
