## MEMORANDUM

After careful consideration of the matter, the undersigned is directed by order of the Governor to state that the remaining 50% of the third installment of arrear due to revision of Pay and Allowances as per recommendation of the 5<sup>th</sup> Pay Commission (ROPA Rules 2009) will be paid to the approved teaching and non-teaching employees of recognized Government Aided/Sponsored Educational institutions and Madrashas as listed in Annexure I (Sl. No. 1-15).
