Subject: Implementation of the West Bengal Health Scheme, 2008—completion of enrolment within 31.12.2010

Dear Sir.

I would like to draw your kind attention to the Notification No. 8014-F (MED), dt. 30.07.10 and Memo No. 8016-F (MED), dt. 30.07.10 on the above subject (Copies enclosed).

- (2) I would like to inform you that enrolment of the existing employees of the State Government under the Scheme shall be completed within 31.12.10. New entrants into Government Service shall be allowed two years time limit to complete their enrolment under the Scheme.
- (3) The enrolment of the retired Government employees of the State Government who were not enrolled under the Scheme while in service shall be completed within 31.12.10. The State Government employees who retired on superannuation and were enrolled under the Health Scheme while in service shall be allowed one year time limit to complete enrolment under the Scheme.
- (4) The existing employees and pensioners not opting to come under the Scheme following Notification No. 8014-F (MED), dt. 30.07.10 and Memo No. 8016-F (MED), dt. 30.07.10 shall not be eligible to get the benefits of the Scheme.
- (5) I would like to request you that various provisions of the West Bengal Health Scheme, 2008 along with Notification No. 8014-F (MED), dt. 30.07.10 and Memo No. 8016-F (MED), dt. 30.07.10 may kindly be brought to the knowledge of all the officers and employees under your control so that they may take conscious decision regarding enrolment under the Scheme. Workshops/ interactive sessions may also be conducted.
- (6) The West Bengal Health Scheme, 2008 with latest circulars and memos are available in the official website of the Finance Department www.wbfin.nic.in link W.B. Health Scheme, 2008.

The Governor is pleased to make the following amendment to the West Bengal Health Scheme, 2008 as amended under notification no. 6722-F dt. 09-07-2009:-

In Clause-3

for Sub-Clause (e)(ii), the following Sub-Clause shall be substituted:-

(e)(ii) Parents whose monthly income does not exceed Rupees Three Thousand Five Hundred;

Note:- In case of pensioners, income from all sources including pension before commutation is to be taken as income. However, the dearness relief on pension is not to be considered as income.

The amendment is effective from 01-09-2010.
