No. 54-L.—10th January, 2014.—The following Act of the West Bengal Legislature, having been assented by the Governor, is hereby published for general information:—

**West Bengal Act XXI of 2013**

THE WEST BENGAL CORRECTIONAL SERVICES  
(SECOND AMENDMENT) ACT, 2013.

[Passed by the West Bengal Legislature.]

*An Act to amend the West Bengal Correctional Services Act, 1992.*

WHEREAS it is expedient to amend the West Bengal Correctional Services Act, 1992, for the purpose and in the manner hereinafter appearing;

West Ben. Act  
XXIII of 1992.

It is hereby enacted in the Sixty-fourth Year of the Republic of India, by the Legislature of West Bengal, as follows:—

Short title and  
commencement.

1. (1) This Act may be called the West Bengal Correctional Services (Second Amendment) Act, 2013.

(2) It shall come into force on such date as the State Government may, by notification in the *Official Gazette*, appoint.
