**Sub: Temporary withdrawal of 'On-line Re-appropriation System'**

The Government in Finance Department decentralised the power of re-appropriation from the Finance Department to the concerned Administrative Department by introducing 'On-line Re-appropriation System' on and from 01.09.2013 vide Notification No.705-F.B. dated 09.08.2013.
