***Sub : Grant of Dearness Relief on Pension to the teaching and non-teaching Pensioners / Family Pensioners of the of State aided Non-Government Educational Institutions and Pensioners of statutory Bodies/Govt. undertakings etc. under the administrative control of the School Education Department with effect from 1<sup>st</sup> January, 2015.***

In supersession of the rates mentioned in Finance Department's earlier Order No. 552-F(Pen) dated the 24<sup>th</sup> December, 2013 sanctioning installment of Dearness Relief to the State Government Pensioners/Family Pensioners w.e.f. 1<sup>st</sup> January, 2014 onwards and in pursuance of Finance Department's memo no. 12-F(Pen) dated the 9<sup>th</sup> January, 2015, the undersigned is directed by order of the Governor to say that the Governor is pleased to direct that the teaching and non-teaching Pensioners/Family Pensioners of recognized State aided Non-Government Educational Institutions under this Government and Pensioners of statutory Bodies/Govt. undertakings etc. under the administrative control of the School Education Department, who are in receipt of Dearness Relief at State Government rates i.e. 58% of Basic Pension with effect from January 1, 2014, shall draw Dearness Relief on monthly Pension / Family Pension @65% of Basic Pension/Basic Family Pension with effect from the 1<sup>st</sup> January, 2015.

2. Payment of Dearness Relief on Pension/Family Pension sanctioned hereinabove involving a fraction of rupee shall be rounded off to the next higher rupee.

3. It will now be the responsibility of the Pension Disbursing Authority to calculate the quantum of relief on Pension/Family Pension payable to each individual case and to make necessary adjustment of overpayment / underpayment, if any.

4. For the purpose of payment of Dearness Relief sanctioned herein, the Principal Accountant General (A&E), West Bengal, will issue authority to the Public Sector Banks in Kolkata and the Accountant General of other States.

5. The Treasury/Sub-Treasury Officers in this State will give effect to this order without the authority of the Accountant General (A&E), West Bengal.

6. This order issues in terms of Finance Department, Pension Branch's Memo No. 12-F(Pen) dated the 9<sup>th</sup> January, 2015.

7. All concerned are being informed accordingly.
