NOTIFICATION

It has been observed that this Department is facing difficulties to ensure occupancy of residential quarters of the occupants after necessary repair works as the Superintending Engineers are solely empowered to accord technical sanction to estimates for ordinary repair works in residences as per the extant policy of this Department as laid down in Schedule B, Part-II – WORKS AND THEIR EXECUTION, Serial No.26 of PWD Code, Volume-I, Page 140.

Hence, after careful consideration of the entire matter, the Governor is pleased to make the following amendments relating to the empowerment to accord technical sanction to estimates for ordinary repair works in residences as laid down in Schedule B, Part-II – WORKS AND THEIR EXECUTION, Serial No.26 of PWD Code, Volume-I, Page 140.


