NOTIFICATION

WHEREAS, the State Government in compliance of the directions of the Hon'ble Supreme Court in S.L.P.(C) No. 23984/2010 and 25237/2010 issued Notification No. 2516-WT/3M-98/2006 dated 19.06.2014 in the matter of entitlement of the dignitaries, officers and operational agencies for use of certain specific kinds of lights on vehicles to be used by them in this State;

AND, WHEREAS, the State Government has now felt it necessary and expedient to revisit the aforesaid Notification on a reference made by the Ld. Legal Remembrancer, West Bengal with regard to the specific kind of light to be used on the top front of the vehicle of Ld. Advocate General, West Bengal in this State;

NOW, THEREFORE, the State Government is hereby pleased to notify in partial modification of this Notification No. 2516-WT/3M-98/2006 dated 19.06.2014 and in terms of Clause (iii) of the proviso to Rule 108(1) of the Central Motor Vehicles Rules, 1989 that the Advocate General, West Bengal shall be entitled to use **Red Light with flasher** on top front of his vehicle in this State.

This comes into force with immediate effect.
