The data is to be collected in **soft** as well as **hard copies** from the Madrasahs and must be checked and verified at his office before submission of the same to the concerned DOMA/Officer-in-charge, Minority Cell for transmitting the same to this office through e-mail immediately as well as in printed format in due course. The Computer Operators attached to DOMA Offices will make entry in software by 15.05.2015 through the link <http://wbmadrasahdte.gov.in/LogUser.aspx>. For large number of Institutions, Malda and Murshidabad district should complete the entry work within 30.05.2015.

You are requested to ensure collection of the data of all recognized aided Madrasahs in the prescribed format and submission of the same after verification and authentication by you to the concerned DOMA/Officer-in-charge, Minority Cell within **30th April 2015** so that the same may be transmitted to this office in time.

The enrolment of class I to class X is required to be furnished as on 31.03.2015. The enrolment figure of class XI and class XII is to be furnished separately as on 31.03.2015.

The data is urgently required for getting fund for various development works of the Madrasahs. The Madrasahs who will fail to supply data, they may not be entitled to get the fund.
