**Sub : Re-employment of 88 retired Ward Master in different Government Hospital.**

The undersigned is directed by order of the Governor to say that the Governor has been pleased allow re-employment 88(eighty eight) retired Ward Master at a consolidated remuneration of Rs.14,000/-p.m. or the remuneration applicable to a re-employed employee as per Finance Department's Order No.3951-F dated 27/05/2009 whichever is less, for a period of 6(six)months in the different Government hospital in view of smooth-functioning. Age of a retired Ward-Master should not exceed 64 years on the date of joining in terms of Finance Deptt.'s no.115-F(P) dated 04/01/2012

The selection criteria of the re-employed Ward Master should be the following:

1. He/she must be physically & mentally fit.
2. He/she must have a good record of performance during service period.
3. The less will be the age, the more will be the chance of selecting for the re-employment.


