MEMORANDUM

Sub: Amendment in procedure for suspension and debarment of suppliers, contractors and consultants.

Public Works Department vide its Memorandum No.547-W(C)/1M-387/15 dated 16.11.2015 has laid down detailed procedure for suspension and debarment of suppliers, contractors and consultants, who are participating in the tender process as well as selected for execution of public works, for their declaration or forgery or falsification of records submitted or failure to execute committed contract or for their failure to perform contractual obligations and thereby resulting delay in execution of the public works or execution of faulty works.

2. When an agency is debarred as per the guidelines laid down in the aforesaid Memorandum, a formal debarment order is issued in the name of the debarred agency and the name of such agency is uploaded in official website of PWD for display as per Clause 3.3 of the said Memorandum.

3. During the recent past, a number of agencies have come up with petitions to remove their names from the list of debarred contractors uploaded in official website of PWD after expiry of their debarment period because their names are still being displayed in the website even after termination of their debarment period. This results in disqualification on the part of the contractors to participate in e-NIT for new schemes.

4. Now, after careful consideration of the entire matter, the undersigned is directed to make following amendment to Clause 3.3 of Memorandum No.547-W(C)/1M-387/15 dated 16.11.2015 of Public Works Department as detailed hereunder:






