Sub : Grant of Dearness Allowance to the Teaching and Non-teaching employees of Non-Government Aided/ Sponsored Educational Institutions who are in the pre-revised scale of pay/ Employees of Statutory Bodies / Govt. Undertakings / Local Bodies etc. with effect from the 1st January, 2017.

The undersigned is directed by order of the Governor to say that the Governor is pleased to direct that all the whole time approved employees of Statutory Bodies/Govt. Undertakings /Local Bodies etc. under the administrative control of this Department, who are in receipt of Dearness Allowance at State Government rates i.e. 75% of Band Pay and Grade Pay taken together with effect from January 1, 2016, shall draw Dearness Allowance @85% with effect from the 1st January, 2017, in terms of Finance (Audit) Department's memo no. 19[65]-F(P2) dated the 2nd January, 2017.

2. The Dearness Allowance sanctioned hereinabove shall be rounded off to the nearest rupees, in each case.

3. In case of Public Undertakings / Statutory Bodies the additional expenditure should be borne by such Undertakings / Bodies themselves out of their own resources or out of the financial assistance provided to them in the budget and that no additional financial assistance will be given to them on account of sanction of Dearness Allowance.

4. The undersigned is further directed to enclose a copy of the Memo No. 20-F(P2) dated the 2nd January, 2017 received from the Finance Department, Audit Branch, Govt. of West Bengal, regarding Grant of Dearness Allowance to the State Govt. employees / Teachers and non-teaching employees of Non-Govt. aided / Sponsored Educational Institutions / Employees of Statutory Bodies/Govt. Undertakings / Panchayats including Panchayats Karmee and Municipal Corporation / Local Bodies etc. **who are drawing their pay in the pre-revised scale of pay**, for information and necessary action at their end.

5. This order issues in terms of Finance (Audit) Department's Memo No. 19[65]-F(P2) dated the 2nd January, 2017 and Memo No. 20-F(P2) dated the 2nd January, 2017.

Sub : Grant of Dearness Allowance to the State Government Employees / Teachers and Non-Teaching Employees of Non-Government Educational Institutions / Employees of Statutory Bodies / Government Undertakings / Panchayats including Panchayat Karmee and Municipal Corporations / Municipalities, Local Bodies etc. who are drawing their pay in the pre-revised scale of pay with effect from January 01, 2017.

The undersigned is directed to refer to this Department's Order No.18-F(P₂), dated 02.01.2017 revising the Dearness Allowance with effect from 01.01.2017 in respect of the State Government Employees / Teachers and Non-Teaching Employees of Non-Government Educational Institutions / Employees of Statutory Bodies / Government Undertakings / Panchayats including Panchayat Karmee and Municipal Corporations / Municipalities, Local Bodies etc. who are drawing their pay in the pre-revised scale of pay.

The rates of Dearness Allowance to above categories of employees shall be enhanced from the existing rate of 156% to 173% with effect from 01.01.2017. All other conditions as laid down in 10902-F(P), dated 09.12.2009 will continue to apply.

The Dearness Allowance sanctioned hereinabove shall be rounded off to the nearest rupee in each case.

It has also been decided that in the case of Public Undertaking / Statutory Bodies the additional expenditure should be borne by such Undertakings / Bodies themselves out of their own resources or out of financial assistance provided to them in the budget and that no additional financial assistance will be given to them on account of sanction of Dearness Allowance.


