**MEMORANDUM**

**Sub: Enhancement the limit of estimated value to Rs. 10.00 Crore (Rupees Ten Crore) instead of Rs. 1.00 Crore (Rupees One Crore) for Clause B & C of the Finance Department's Memorandum No. 925-F(Y) dated 14<sup>th</sup> February, 2017**

Recently, in the Finance Department's Memorandum No. 925-F(Y) dated 14<sup>th</sup> February, 2017, considerable changes have been incorporated in comparison to the Finance Department's earlier Memorandum No. 9754-F(Y) dated 03.12.2012 regarding acceptance of tender during 2<sup>nd</sup> call.

2. The Memorandum No. 925-F(Y) dated 14<sup>th</sup> February, 2017, has made a mandatory provision for all tenders where qualified bidders are less than 3 at the tender/re-tender/re-auction during 2<sup>nd</sup> call for estimated value more than Rs. 1.00 Crore requires Finance Department's concurrence.

3. In PWD, a large number of cases had to be referred to Finance Department due to the said limit of Rs. 1 crore for referring the matter to Finance. This was leading to delay in finalisation of agency and consequent delay in works. The matter was referred to Finance Department for enhancing the limit.

4. After careful consideration of the matter, the Finance Department enhanced the limit to Rs. 10.00 Crore instead of Rs. 1.00 Crore for PWD in relaxation of Clause B & C of Memorandum No. 925-F(Y) dated 14<sup>th</sup> February, 2017 vide their U.O. No. Group T/2017-2018/0080 dated 02.05.2017.

5. In the light of above the undersigned is directed to enhance the limit for all tenders where qualified bidders are less than 3 at the tender/re-tender/re-auction during 2<sup>nd</sup> call of estimated value Rs. 10.00 Crore (Rupees Ten Crore) instead of Rs. 1.00 Crore (Rupees One Crore) in relaxation of Clause B & C of Finance Department's Memorandum No. 925-F(Y) dated 14<sup>th</sup> February, 2017.

6. This order issues with the concurrence of the Finance Department, Group T vide their U.O. No. Group T/2017-2018/0080 dated 02.05.2017.


7. This order will take immediate effect.
