***Sub : Grant of Dearness Allowance to the Teaching and Non-teaching employees of Government Aided/ Sponsored Educational Institutions with effect from 1<sup>st</sup> January, 2019.***

The undersigned is directed by order of the Governor to say that the Governor is pleased to direct that all whole time approved teaching and non-teaching employees of recognized Government Aided/ sponsored Educational Institutions, both Primary and Secondary (including Higher Secondary), who are in receipt of Dearness Allowance at State Government rates i.e. 100% of Band Pay and Grade Pay taken together, with effect from January 1, 2018, shall draw Dearness Allowance @125% with effect from the 1<sup>st</sup> January, 2019, in terms of Finance (Audit) Department's Memo No. 4037-F(P2) dated the 21<sup>st</sup> June, 2018.

2. The Dearness Allowance sanctioned hereinabove shall be rounded off to the nearest rupees, in each case.

3. The Governor has further been pleased to direct that this additional instalment of Dearness Allowance payable in terms of this order shall be paid along with the Salary, through Banks, to all employees of Government Aided/Sponsored Educational Institutions both Primary and Secondary and other organizations, irrespective of their basic pay, with effect from 1<sup>st</sup> January, 2019.

4. This order issues in terms of Finance (Audit) Department's Memo No. 4037-F(P2) dated the 21<sup>st</sup> June, 2018.
