## ORDER

Enhancement of consolidated remuneration of Para Teachers (both primary and upper primary), Siksha Bandhu, VRPs, Special Educators and other associated with PBSSM was allowed Vide memo no. 273-SE(P)/PBRPSUS/ADMN/9/04-05 dated 23.4.10 of School Education Deptt., Govt of West Bengal and their consolidated remunerations were tixed as given below:


Thereafter vide Order No. 376-SE(Pry) dated 9.6.2010 of School Education Depth. Govt. of West Bengal, counting from 1st June 2010, allowed enhancement @ 5% of every interval of 3 years for them.

Subsequently the consolidated remuneration payable to the VRPs was rationalized vide Order No.790 SE(Pry)PBRPSUS/ADMN/9/04-05 (Pt.II) dated 11th October 2012 of School Education Deptt. w.e.f 1st September 2010 and it was fixed at Rs. 5400/- p.m. Further in pursuance of Order No. 455-SE (Pry)/PBSSM/Ped/36/07-08 dt. 15th July 2013 VRPs were re-designated as Para Teacher (Primary) and given the status as such.

Accordingly, it is hereby ordered that enhancement @ 5% of the consolidated remuneration for the above categories of persons will be allowed effective from 1th June 2013. For the purpose of calculation, the enhanced consolidated remuneration paid/payable in the month of June, 2010 will be considered for all except for VRPs (the re-designated Para Teachers - Primary) and in their case the rationalized monthly remuneration of Rs. 5400/- paid/payable in September, 2010 will be considered.

Only those personnel who were on the roll as on 1<sup>st</sup> June 2010 and who have completed three years service as on 1<sup>st</sup> June. 2013 are eligible. VRPs will be considered on roll as on 01/6/2010 if the person was on roll as VRP as on 1<sup>st</sup> June 2010 and has completed three years as on 1<sup>st</sup> June 2013 taking the fenure of VRP and re-designated Para Teacher-Primary together.

This enhanced remuneration will be drawn in the remuneration bill of July, 2013 onwards and continue to be drawn until further order. The enhancement amount

will be rounded to the nearest rupee. The arrears for the month of June 2013 will also be paid.

All concerned are requested to take necessary action accordingly.
