Sub : **Postponement of Election for Constitution /Reconstitution of the Managing Committee/Ad-hoc committee/Organizing Committee/Administrator up to 23.07.2019. of Recognised Junior High, High and Senior Madrasah in view of ensuing Parliamentary Election 2019 declared by Election Commission, Govt. of India.**

In exercise of the powers conferred by Sub – section (2) of Section 21 of West Bengal Board of Madrasah Education Act 1994, the President is pleased to notify for general information that in view of the Election in Parliamentary Constituencies, declared by the competent authority through notification and enforcement of Model Code of Conduct with effect from 10.03.2019 to 23.07.2019, the process of Constitution/ Reconstitution of the Managing Committee in Madrasahs shall remain suspended from the date of notification of the Model Code of Conduct to the date of declaration of result of the Election in the Parliamentary Constituencies.

1. In cases of Madrasahs where the process of Election for different stages have already been started but not completed till 10.03.2019, the remaining part shall be started after 23.07.2019 adopting programmes afresh as per normal rules and procedure.
2. In cases of Madrasah where Elections of different categories other than office Bearers have already been completed prior to declaration of the date of enforcement of Model code of Conduct for the ensuing Election i.e from 10.03.2019 the election of Office Bearers shall stand deferred upto 23.07.2019.
3. In case of Madrasahs where election is due but have not yet adopted any programme for Election will take steps for the Constitution /Reconstitution of the Managing Committee as per Rule after. 23.07.2019.
4. The tenure of the Managing Committee/ Ad-hoc Committee/ Organizing Committee/ Administrator of the Madrasahs of West Bengal is extended from 10.03.2019 upto 23.07.2019.
5. The tenure of the Managing Committee/ Ad-hoc Committee/ Organizing Committee/ Administrator of the Madrasah has already been expired before 10.03.2019 should apply separately to the office of the West Bengal Board of Madrasah Education.
6. The Board however reserves the right to appoint Administrator /Ad-hoc committee where the same would be necessary for administrative reasons
7. The above Notification is not applicable to Madrasahs where any order from the Hon'ble Court prevails.
