WHEREAS, Public Works Department, Government of West Bengal issued a Memorandum vide No:07-W(C)/1M-204/15(Pt) dated 17.07.2015 laying down procedures regarding execution of emergent works at Short tender notice;

NOW, after careful consideration of the entire matter, the Governor is pleased to make necessary modification in Para 2 of the aforesaid Memorandum vide No:07-W(C)/1M-204/15(Pt) dated 17.07.2015 as follows:

Existing Para 2 of the Memorandum vide No:07-W(C)/1M-204/15(Pt) dated 17.07.2015

"With view to avoiding such situations, it has been decided that apart from specifying formalities situations, detailed tender would be prescribed so as to ensure appropriate financial competence Division or circle level Offices, provided the value of such works shall be restricted to a maximum limit of Rs 1 Crore. Accordingly, Governor is pleased to prescribe following procedure for execution of works at a short tender notice."

Modified Para 2 of the Memorandum vide No:07-W(C)/1M-204/15(Pt) dated 17.07.2015

"With view to avoiding such situations, it has been decided that apart from specifying situations, detailed tender formalities would be prescribed so as to ensure appropriate financial competence for Division or circle level Offices, provided the aggregate value of such works in one emergent situation / occasion shall be restricted to a maximum limit of Rs 1 Crore. Accordingly, Governor is pleased to prescribe following procedure for execution of works at a short tender notice."
