**ADDENDUM**

This is an addendum to the Guideline bearing No.738-SE (law) /SL/5S-356/18, dated: 26.06.19 in relation to the Guidelines for Child Safety from Sexual Abuses in the School whereby the following additions have been made:

1. Time period of 1, 2 and 3 months, as and where appears in the Guideline for taking necessary action by the concerned authorities, will be read as 3, 4 and 6 months respectively, except in page 15 point 8(d) where the time period of 1 month remains unchanged.
2. In the list of the members of the District Level Nodal Committee (POINT 3) in page 38 of the Guideline, Sl. No. 1 and 2 have been extended as stated below:
  - (a) District Magistrate for all Districts other than Kolkata and Commissioner of Kolkata Corporation for Kolkata District.-  
Chairman
  - (b) Superintendent of Police of the District for all Districts other than Kolkata and Deputy Commissioner of Kolkata Police for Kolkata District. – Member
  - (c) Chairman, District Primary School Council has been inserted under Sl. No. 5 as a member, re- numbering the other members accordingly thereafter.
3. The duly signed Notification bearing No.740-SE (LAW)/SL/5S-356/18 dated: 26.06.19 has been inserted in the Guideline after The Disclaimer and before the Contents page.

3. There shall be District Level Nodal Committee under the leadership of concerned District Magistrate with following members:

2.	Superintendent of Police of the <b>District for all Districts other than Kolkata and Deputy Commissioner of Kolkata Police for Kolkata District.</b>	Member
3.	DIS (SE)	Member-Convener
4.	DPO, SSM	Member
5.	<b>Chairman,, District Primary School Council</b>	<b>Member</b>
6.	DIS (PE)	Member
7.	District Social Welfare Officer.	Member
8.	An expert with law background to be nominated by DM.	Member
9.	Any other member(s) to be co-opted by the Nodal Committee	Member(S)

Similar activities have to be performed by the Committee as applicable to State level Nodal Committee.

4. There shall be Sub-Divisional Committee for all the Sub-Divisions covering all Districts except Kolkata under the leadership of concerned Sub-Divisional Officer comprising of the members as may be selected by SDO concerned. The District and/or Sub-Divisional Committee shall assist the State Nodal Committee and shall perform such activities as entrusted by the State Level Committee.

Similar activities have to be performed by the Committee as applicable to State level Nodal Committee.

5. The State Nodal Committee shall prepare and furnish the annual report to the State Government in respect of their performance.

6. For the purpose of this notification, "School" means any school from Pre-Primary to Higher Secondary level which receives aid from the State Government to maintain its' affairs. It also includes the unaided school(s) affiliated to the Board(s), Council constituted under the Act(s) of the West Bengal State Legislature.

7. This shall have immediate effect, until further order.


