MEMORANDUM

Subject : Ad-hoc Bonus for the year 2020-2021.

A question has been raised whether IT personnel namely Data Entry Operator/Computer Operator etc. brought under direct engagement under Government as Contractual Worker discontinuing Agency contract in terms of Notification No. 192-IT dated 16.10.2020 are eligible for Ad-hoc Bonus for the year 2020-2021.

After careful consideration of the matter, the undersigned is directed by order of the Governor to decide that any contractual employee having rendered at least six months service during the year after being brought under the purview of Notification No. 192-IT dated 16.10.2020 together with the service rendered in Government establishments through Agency shall be eligible for Ad-hoc Bonus for the year 2020-2021 as per para 2(v) of Memo No. 1491-F(P2) dated 06.05.2021 on fulfillment of other terms and conditions of the said Memo.

Payment shall be made as per the terms and conditions mentioned in Memo No. 1491-F(P2) dated 06.05.2021.
