## **MEMORANDUM**

Schematic Bank Account Management System (SBMS) has already been introduced in IFMS for management of operations of Bank Accounts in connection with Schematic funds disbursed through those Bank Accounts for different Schemes in terms of Memo No. 2603-F(Y) dated 30/04/2019 of the Finance Department, West Bengal.

Consequently the Institutional Bank Accounts shall have to be mandatorily registered in SBMS for receiving Scheme wise Funds in those Bank accounts and further making all Schematic transactions and operations through them. Such process of Integration was completed in respect of 18 (Eighteen) Banks in total in three phases vide the memorandum, ibid and Memo No. 3545-F(Y) dated 25/06/2019 and Memo No. 4565-F(Y) dated 13/08/2019 respectively. In the mean time the Integration process of some more Banks, in addition to the existing 18 (Eighteen), with SBMS Module have already been completed.

Thus, in continuation to Annexure III of Memo No. 2603-F(Y) dated 30/04/2019, Memo No. 3545-F(Y) dated 25/06/2019 and Memo No. 4565-F(Y) dated 13/08/2019 of the Finance Department, West Bengal, the Governor is pleased to declare following Banks to have been integrated with SBMS Module in addition to the existing integrated Banks:

- 1. Allahabad Bank;
- 2. Bank of India;
- 3. Bank of Baroda;
- 4. West Bengal State Co-operative Bank Ltd.

This order will take immediate effect.
