NOTIFICATION

No. 49-EMP/1M-25/98.—1st March 2011.—At present the State Government is following reservation of 2% vacancies in the rank of Constables in the West Bengal Police Directorate for recruitment of Meritorious Sportspersons. Extension of similar benefits of reservation in Group 'B', 'C' and 'D' posts for Meritorious Sportspersons has been under active consideration of the Government for some time.

2. After careful consideration, the Governor is pleased to direct that 2% of the vacancies in Group 'B', 'C' and 'D' posts, occurring henceforth, shall be reserved for filling up from the Meritorious Sportsperson in the following list of sports:

(i) Athletics [including Track and Field events], (ii) Badminton, (iii) Basket Ball, (iv) Cricket, (v) Football, (vi) Hockey, (vii) Swimming, (viii) Table Tennis, (ix) Volley Ball, (x) Tennis, (xi) Weightlifting, (xii) Wrestling, (xiii) Boxing, (xiv) Cycling, (xv) Gymnastics, (xvi) Judo, (xvii) Rifle Shooting, (xviii) Kabaddi and (xix) Kho-kho.

3. In order to be eligible, the candidate must produce requisite certificates issued by the respective Competent Authorities as follows :

Area	Competent Authority
International Competition	Secretary of the National Federation/National Association of the Sports concerned (Form No. 1 as annexed).
National Competition	Secretary of the State Association of the Sports concerned (Form No.2 as annexed).

Area	Competent Authority
Inter-University Tournament	Dean/Director of Sports or other officer in overall charge of Sports of the University concerned (Form No. 3 as annexed).
National Sports/Games for School Education	Director or Deputy Director in overall charge of Sports/Games of schools in the Directorate of School Education, West Bengal (Form No.4 as annexed)

4. The Governor is further pleased to direct that the following categories of Meritorious Sportspersons shall be given preference in recruitment :
- (a) Those that have represented West Bengal or India in a National or International Competition in sports discipline mentioned above ;
 - (b) Those that have represented a University in an Inter-University Tournament conducted by Inter-University Sports Board in any sports discipline mentioned above ;
 - (c) Those that have represented State School Teams in National Competition for Schools conducted by all India School Games Federation in any sports discipline mentioned above.
5. This provision will not affect the existing order relating to reservation Acts/Rules in force.
6. Amendment in relevant statutes and rules of recruitment in State Government Establishments and Establishments of Public Undertakings, Statutory Bodies, Government Companies and Local Authorities shall be made, wherever necessary.
