The matter of revision of rates of Administrative Allowance/Special Allowance for the field level WBCS(Exe) officers e.g. Sub-Divisional Officer, Additional District Magistrate & District Magistrate has been under consideration of the Government for sometime past.

In partial modification of this Department's Memorandum No.234-PAR(IAS)/8P-04/2017 dated 7th February, 2017 read with Notification No.180-PAR(WBCS)/1D-34/21 dated 08.02.2021, the Governor is now pleased to decide that the above mentioned WBCS(Exe) officers would be entitled to draw 'Administrative Allowance/Special Allowance' at the following revised rates:-

Field Level Officer	Existing Allowance	Revised Allowance
Sub-Divisional Officer	Rs.1200/- per month	Rs.2000/-per month
Additional District Magistrate	Rs.1200/- per month	Rs.2500/-per month
District Magistrate	Rs.1300/- per month	Rs.3000/-per month

3. The revised rates will come into effect from 01.05. 2022


