Integration of 1(One) new Bank in SBMS Module.

Schematic Bank Account Management System (SBMS) has already been introduced in IFMS for management of operations of Bank Accounts dealing with Schematic Fund disbursed through those Bank Accounts for different Schemes in terms of Memo No.2603-F(Y) dated 30/04/2019 of Finance Department, West Bengal.

Consequently, the Institutional Bank Accounts shall have to be mandatorily registered in SBMS for receiving Schematic Fund in those Bank Accounts and further making all Schematic transactions and operations through them. Such process of integration was completed with 26 banks vide the Memorandum, ibid and Memo No.3545-F(Y) dated 25/06/2019, Memo No.4565-F(Y) dated 13/08/2019, Memo No.5920-F(Y) dated 31/10/2019 Memo No.7080-F(Y) dated 31/12/2019 Memo No 258-F(Y) Dated-27/01/2022 and Memo No.2861-F(Y) Dated-.12/07/2022 of Finance Department, Government of West Bengal respectively.

Thus, in continuation of above stated all Memorandum of Finance Department, Government of West Bengal, the Governor has been pleased to declare following Bank to have been integrated with SBMS Module in addition to the existing integrated Banks:
