NOTIFICATION

Whereas, a proposal had been submitted for introduction of two new auto-rickshaw routes from (1) Chetla Road to Kalighat Metro and (2) Chetla Road to Hazra Khirod Ghosh Market; and

Whereas, Regional Transport Authority, Kolkata obtaining NOC from Dy. Commissioner of Police, Traffic Department, Kolkata vide No.TP/PA/I/76263 dated 24.08.2021 placed the matter in its meeting held on 25.01.2022 and decided to approve the proposal for introduction of the two new auto-rickshaw routes from (1) Chetla Road to Kalighat Metro via. Shyam Bose Road, P.M. Roy Road, Chetla Central Road, Rashbehari Avenue and (2) Chetla Road to Hazra Khirod Ghosh Market via. Gopal Nagar Road, Judges Court Road fixing the fleet strength as 20 (twenty) for each of these two routes; and

Whereas, the Chairman, Regional Transport Authority, Kolkata & Additional Director, Kolkata Zone Transport Directorate, West Bengal vide his Memo No.RTA/332(Con) dated 08.02.2022 has requested for publication of Notification introducing the said routes; and

Whereas, Notification No.5673 -WT/3M-01/2010 Pt.II dated 10.12.2018 issued directing the RTA, Kolkata to limit the number of permits on auto-rickshaw plying in different routes within the jurisdiction of Kolkata, Howrah, Bidhannagar and Barrackpore Police Commissionerates;

NOW, THEREFORE, in exercise of the powers conferred under clause (a) of sub-section (3) of section 74 of the Motor Vehicles Act, 1988 (Act of 59 of 1988) as amended and in partial modification of Notification No.5673 -WT/3M-01/2010 Pt.II dated 10.12.2018, the Governor is hereby pleased to introduce the following auto-rickshaw routes in the interest of public:

Sl. No.	Name of the Auto-rickshaw Route	Maximum number of Permit
1	Chetla Road to Kalighat Metro via. Shyam Bose Road, P.M. Roy Road, Chetla Central Road, Rashbehari Avenue	20
2	Chetla Road to Hazra Khirod Ghosh Market via Gopal Nagar Road, Judges Court Road	20

This will come into immediate effect.


