In exercise of the power conferred by section 21 of the West Bengal State Health Services Act, 1990 (West Ben. Act VII of 1990), the Governor is pleased hereby to make the following amendment in the West Bengal Medical Education Service, West Bengal Health Service and the West Bengal Public Health-cum-Administrative Service (Placement on Trainee Reserve) Rules, 2015 (hereinafter referred to as the said rules);

## **Amendment**

In rule 3, in clause (b) of the said rules, -

- (1) In sub-clause (ii), after the words 'shall only be allowed to do so', insert the words 'except the disciplines of Anatomy, Physiology, Pharmacology and Forensic Medicine';
- (2) In clause (iii), for the proviso, substitute the following proviso:

"Provided that the Officers of the rank of Basic Public Health-cum-Administrative Officer as defined in rule 2 of the West Bengal Public Health-cum- Administrative Service (Cadre) Rules 2004, shall only be eligible for trainee reserve facilities for prosecuting the courses enumerated in sub-clause (ii) of clause (b) except the disciplines of Anatomy, Physiology, Pharmacology and Forensic & State Medicine as Government Sponsored candidates;"
