MEMORANDUM

The question of enhancement of professional fee / remuneration of Data Entry Operators (DEOs) engaged under No. 5859-F(Y) dated 22/07/2013 has been under active consideration of the Government for some time past.

2. After careful consideration, the undersigned is directed by order of the Governor to say that the Governor is pleased to revise professional fee / remuneration of DEOs engaged under No. 5859-F(Y) dated 22/07/2013 in the following manner w.e.f 01/04/2023:

Designation	On fresh engagement and yearly enhancement thereafter	On completion of 5 years and yearly enhancement thereafter	On completion of 10 years and yearly enhancement thereafter	On completion of 15 years and yearly enhancement thereafter
Data Entry Operator (DEO)	Rs. 16000/-	Rs. 20000/-	Rs. 25000/-	Rs. 31000/-
	Rs. 600/-	Rs. 700/-	Rs. 800/-	Rs. 1000/-

3. Data Entry Operators engaged under No. 5859-F(Y) dated 22/07/2013 who have subsequently been brought or will be brought under the purview of Notification No. 192-IT/06/2020/P & AR-e-Gov. dated 16/10/2020 shall come under the purview of this order.
4. Professional fee / remuneration of the above Data Entry Operators shall be fixed in the above revised structure of remuneration based on the length of service already rendered by them counting from their initial date of engagement irrespective of the professional fee / remuneration drawn by them before 01/04/2023.
5. Annual enhancement of professional fee / remuneration of the above Data Entry Operators may be allowed on the 1st July every year provided at least 6 months of satisfactory service from the date of engagement or last enhancement, as the case may be, has been rendered.
6. Other existing terms and conditions of service in respect of Data Entry Operators engaged under No. 5859-F(Y) dated 22/07/2013 shall remain unaltered.
