
MEMORANDUM

In continuation of the Memo No 1218-F(eGov) dated 07.03.2024, the Governor is pleased to inform that GRIPS has been integrated with “**Uttar Suvidha portal**” of Transport Department for receipt of fees related to online booking and facilitation system for goods vehicles transiting through West Bengal from Assam and North East under the following heads of accounts:
