32705 no of posts of Assistant Teacher have been allotted for classes upto secondary level in Secondary Govt. aided schools and 4362 no of posts of Assistant Teacher for 2181 new set up upper primary schools (2 posts for each school) which have got recommendation within 31st 2010 and have been expected running of class VII & VIII.

In addition to the above 786 no of posts of Assistant teacher for 262 new set up upper primary schools (3 posts for each school) which do not have any sanction of regular teaching posts, to run the school.

A soft as well as Hard copy of District wise list of schools is annexed herewith for your kind perusal.

2. At the time of subjectwise, mediumwise & category wise distribution of the above noted posts the following points may kindly be noted :-

- The ratio between pass graduate and Hons/ Post Graduate posts shall be 50: 50 for each school.
- Moreover 50% of the above mentioned Hons./ Post Graduate posts shall be distributed for science subjects.
- iii) For schools which have since been upgraded from VIII class Junior High School(VIII class) to Secondary School during 2008-09, 2009-10, 2010-2011 & 2011-2012 posts shall be allotted first to keep PTR 40:1 and for further requirement of additional teaching posts, if any, to maintain the minimum staff strength as per prescribed staff pattern for a secondary school shall immediately be informed to School Education Department.
- iv) For newly set up upper primary schools norms for distribution of posts shall be followed as stated above considering the allocation of posts under this memo.
 - 3. The District Inspector of Schools' (Secondary) may be advised to work out the details of subjectwise, mediumwise & categorywise posts by maintaining 100 point roaster and the same shall immediately be communicated to the concerned Regional School Service Commission. Special attention shall also be given at the time of distribution of posts for the schools with bilingual status or having additional section of other languages like santhali, Nepali and Oriya etc. At the time of school wise distribution of posts particularly for upgraded schools and New set up schools the norms as stated above should be followed properly. If any discrepancy is found at any stage of distribution the department may kindly be informed immediately.
 - 4. The charges on account of salary for regular teachers should be met from the head " 2202- General Education-02-Secondary Education-110-Assistance to Non-Govt Secondary Schools-NP-001-Secondary School for Boys & Girls'(ES)-31-Grantsin-Aid-General-01-salary grants."
 - 5. The charges involved as stated in para (4) above will be reimbursed from SSA as per prescribed guidelines of School Education Department.
