NOTIFICATION

The matter of reorganizing of different Circles of Electrical wing under Public Works Directorate and Circles of Mechanical wing under Public Works (Roads) Directorate specially with the object to implement the concept of three zones namely North Zone, West Zone and South Zone under Public Works Department for better supervision and monitoring of the projects spreading all over the different districts of the state, entrusted to PWD by other Departments was under active consideration of the Government for quite some time past.

2. Now, after careful consideration of the matter as a whole, the Governor is pleased in the interest of public service to reorganize the circles of Electrical wing under Public Works Directorate and Circles of Mechanical wing under Public Works (Roads) Directorate as detailed below :

For Electrical Wing of P.W.Dte.

1. Presidency Electrical Circle, P.W.Dte. renamed from Electrical Circle-I, P.W.Dte. at head quarters Kolkata shall have four Electrical divisions under its administrative jurisdiction, namely

A. Kolkata Electrical Division

- **B. West Kolkata Electrical Division**
- **C. Howrah Electrical Division** erstwhile Mechanical Division-II under Mechanical Circle-II, P.W.(Roads) Dte.

D. IT Division

- **A.** The existing **Kolkata Electrical Division**, head quarter as Kolkata shall have two Electrical Sub-divisions under its control namely
 - a. Writers' Building Electrical Sub-division at Kolkata.
 - b. Lalbazar Electrical Sub-division at Kolkata.
- **B.** The existing **West Kolkata Electrical Division**, head quarter as Kolkata shall have two posts of Executive Engineer (Electrical) within its sanctioned strength. One from the existing sanctioned cadre to be designated as Executive Engineer-I, West Kolkata Electrical Division and other created by transferring the post of Executive Engineer-II from Western Electrical Division-I to be designated as Executive Engineer-II, West

 - a. Howrah Electrical Sub-division at Howrah.
 - b. B.E.College Electrical Sub-division at Howrah.
 - c. Nabanna Electrical Subdivision at Howrah created from the set up of Mechanical Subdivision- III transferred from administrative control of Mechanical Planning Division under Mechanical Circle-I, P.W.(Roads) Dte. The subdivision will look after all the construction and maintenance of electrical works of Nabanna, Howrah.
- **D.** The existing IT Cell, head quarter at Kolkata would be renamed as **IT Division** to look after all IT related works of the department.
- **2. Health Electrical Circle, P.W.Dte.** renamed from Health Circle, P.W.Dte. at head quarters Kolkata shall have three Electrical divisions under its administrative jurisdiction, namely

 - B. Murshidabad Electrical Division newly created Electrical Division.
 - **A. Nadia Electrical Division** head quarter at Krishnanagar, renamed from existing Kalyani Electrical Division will have the two Electrical Sub-divisions under its control namely

 - b. Kalyani Electrical Sub-division erstwhile BCKVV Electrical Subdivision.

Bankura Electrical Sub-division-II at Bankura town renamed and transferred from Electrical Subdivision-VII, P.W.(C.B), under Electrical Division-II, P.W.(C.B), Electrical Circle-III will look after all the original and maintenance of electrical works under P.W.Dept. within the geographical jurisdiction of Bishnupur and Khatra Subdivision.
- **C. Paschim Medinipur Electrical Division** head quarter at Medinipur town, created as a new divisional establishment renaming and transferring Midnapur Electrical Division under Electrical Circle-II, P.W. Dte. shall have two Electrical Sub-divisions under its control namely –

 - b. Midnapur Electrical Sub-division at Midnapur town.

 - A. Birbhum Electrical Division head quarter at Suri created as a new divisional establishment renaming and transferring Mechanical Division-III under Mechanical Circle-II, P.W. (Roads) Dte. shall have two Electrical Sub-divisions under its control namely
 - a. Suri Electrical Sub-division at Suri.
 - b. Bolpur Electrical Sub-division at Bolpur from Electrical Subdivision-VIII, P.W.(C.B).
 - a. Suri Electrical Sub-division at Suri transferred from the administrative control of Western Electrical Division-II, will look after all the original and maintenance electrical works under P.W.Dept. within the geographical jurisdiction of Suri Sadar Sub-division.
 - b.  - b. Alipurduar Electrical Sub-division at Alipurduar.
 - a. Coochbehar Electrical Sub-division at Coochbehar town transferred from the administrative control of Northern Electrical Division, will look after all the

original and maintenance electrical works under P.W.Dept. within the geographical jurisdiction of Coochbehar district except Haldibari zone.

- b. Alipurduar Electrical Sub-division at Alipurduar town transferred from the administrative control of Northern Electrical Division, will look after all the original and maintenance electrical works under P.W.Dept. within the geographical jurisdiction of Alipurduar Sub-division of Jalpaiguri district.
- **B. Jalpaiguri Electrical Division** head quarter at Jalpaiguri town, renaming Northern Electrical Division, P.W. Dte. shall have two Electrical Sub-divisions under its control namely
 - a. Jalpaiguri Electrical Sub-division at Jalpaiguri.
 - b. Malbazar Electrical Sub-division at Malbazar.
 - a. Jalpaiguri Electrical Sub-division at Jalpaiguri town to look after all electrical works under its existing jurisdiction. The Haldibari zone of Coochbehar district will also be looked after by this sub-division.
 - b. Malbazar Electrical Sub-division at Malbazar transferred from the administrative control of Darjeeling Electrical Division, will look after all electrical works under its existing jurisdiction.
- **C. Darjeeling Electrical Division** head quarter at Siliguri shall have three Electrical Sub-divisions under its control namely

 - b. Siliguri Electrical Sub-division-I at Siliguri renamed from Siliguri Electrical Subdivision.

 - c. Siliguri Electrical Sub-division-II at Siliguri transferring and renaming Electrical Subdivision-VI, P.W.(C.B) from the administrative control of Electrical Division-II, P.W.(C.B) under Electrical Circle-III, will look after all electrical works in the Siliguri area particularly Medical College, North Bengal University etc.

 - c. Asansol Mechanical Sub-division at Asansol transferring from administrative control of Mechanical Division-III under Mechanical Circle-II, P.W.(Roads) Dte.
 - d. Bankura Mechanical Sub-division at Bankura town transferring from administrative control of Midnapur Mechanical Division under Mechanical Circle-I, P.W.(Roads) Dte.
 - e. Hooghly Mechanical Sub-division at Bandel transferring from administrative control of Mechanical Division-II under Mechanical Circle-II, P.W.(Roads) Dte.
- **C. South Western Mechanical Division** head quarter at Midnapur town, renaming and transferring Midnapur Mechanical Division from Mechanical Circle-I, P.W.(Roads) Dte. shall have three Mechanical Sub-divisions under its control namely
 - a. Purulia Mechanical Sub-division at Purulia town transferring from administrative control of Burdwan Mechanical Division under Mechanical Circle-I, P.W.(Roads) Dte.
 - b. Paschim Medinipur Mechanical Sub-division at Midnapur town, renaming Midnapur Mechanical Sub-division, P.W.(Roads) Dte.
 - c. Purba Medinipur Mechanical Sub-division at Tamluk renaming Mechanical Subdivision-VII, P.W.(Roads) Dte.
- **A. Southern Mechanical Division** head quarter at Kolkata, renaming and transferring Mechanical Division-I from Mechanical Circle-I, P.W.(Roads) Dte. shall have six Mechanical Sub-divisions under its control namely –

- a. Murshidabad Mechanical Sub-division at Baharampur renaming and transferring Mechanical Sub-division-X from administrative control of Mechanical Division-III under Mechanical Circle-II, P.W.(Roads) Dte.
- b. Nadia Mechanical Sub-division at Krishnanagar renaming and transferring Krishnanagar Mechanical Sub-division from administrative control of Mechanical Planning Division under Mechanical Circle-I, P.W.(Roads) Dte.
- c. North 24 Pargana Mechanical Sub-division at Baguihati renaming and transferring Mechanical Sub-division-II from administrative control of Mechanical Planning Division under Mechanical Circle-I, P.W.(Roads) Dte.
- d. South 24 Pargana Mechanical Sub-division at Kolkata renaming and transferring Mechanical Sub-division-V, P.W.(Roads) Dte.
- e. Howrah Mechanical Sub-division at Uluberia.
- f. Kolkata Mechanical Sub-division at Baguihati renaming and transferring Mechanical Sub-division-I from administrative control of Mechanical Division-II under Mechanical Circle-I, P.W.(Roads) Dte.
- 2. Mechanical Wing Head Quarter, P.W.(Roads) Dte. at Kolkata headed by Additional Chief Engineer / Assistant Chief Engineer, P.W.(Roads) Mechanical shall be created from the establishment of Office of the Additional Chief Engineer, P.W.(Roads) Mechanical. One post of Superintending Engineer (Mech) from the establishment of Mechanical Circle-II will be transferred to this establishment. The Mechanical Subdivisions directly placed under Mechanical Wing Head Quarter are –
 - a. Mechanical Planning Sub-division at Kolkata transferred from administrative control of Mechanical Planning Division under Mechanical Circle-I, P.W.(Roads) Dte.
 - b. R.M.M. Sub-division at Kolkata transferred from administrative control of Mechanical Division-I under Mechanical Circle-I, P.W.(Roads) Dte.
 - c. AE, Machinery at Kolkata transferred from administrative control of Mechanical Planning Division under Mechanical Circle-I, P.W.(Roads) Dte.
 - d. Diamond Harbour Mechanical Sub-division at Diamond Harbour transferred from administrative control of Mechanical Division-I under Mechanical Circle-I, P.W.(Roads) Dte.
 - e. Mechanical Sub-division-VIII at Mecheda transferred from administrative control of Midnapur Mechanical Division under Mechanical Circle-I, P.W.(Roads) Dte.
 - f. Durgapur Mechanical Sub-division at Durgapur transferred from administrative control of Burdwan Mechanical Division under Mechanical Circle-I, P.W.(Roads) Dte.
 - g. Kharagpur Mechanical Sub-division at Kharagpur transferred from administrative control of Midnapur Mechanical Division under Mechanical Circle-I, P.W.(Roads) Dte. The post of A.E.(Mechanical) in this establishment of Kharagpur Mechanical Sub-division will be abolished.
 - 3. For such disassociation and unification of the existing set ups of different divisions and sub-divisions, service of all the existing Directorate cadres as well

as circle cadres under the Electrical and Mechanical Wing of PW Dte. will be maintained in the same directorate and circle respectively. However, service of the number of posts in any particular Directorate/Circle cadre who get posted to other Directorate/ Circle due to this re-organisation shall be treated as deemed deputation. This would not adversely affect the seniority or promotion prospect of any Directorate/Circle staff in any manner. The following terms and conditions are to be maintained:

- i) Existing promotional prospects and seniority of the employees in different cadres under existing circles shall remain unaltered till the end of their service in the same circle establishment as before the re-organization.
- ii) The Vacancies in the lending establishment shall not be filled up.
- iii) After retirement/ promotion or other wise when any post will fall vacant in the lending establishment, the same will stand abolished.
- iv) For creation of any post in the borrowing establishment in the event as stated in (iii) above, concurrence of the Finance Deptt. shall have to be obtained.
- 4. Since four number of Mechanical Division and one Mechanical circle are being converted to Electrical Divisions and Electrical Circle, five posts of Executive Engineer (Electrical) and one number of Superintending engineer (electrical) will be manned by Executive Engineer (Mech) and Supdt,. Engineer (Mech.) respectively till promotion of existing engineering cadres of Mechanical Wing.
- 5. Accounting implications of the establishments shifted and / or transferred for such re-organization & re-jurisdiction will be in the following manner:
- i) The name of the DDOs and the concerned treasury offices of different establishments newly renamed or re-organized under Electrical and Mechanical wing of PW Dte. is enclosed in a separate statement (annexure-I)
- ii) The transfer of Assets and liabilities of account of such re-structuring and rejurisdiction will be maintained in the respective old establishment either renamed or shifted.
- iii) Accounts of the outstanding balances under 8443-PW Deposit, Suspenses, Closing balances etc. with the erstwhile Divisions will be brought forward in the account of respective same divisions either renamed or shifted.
- v) Submission of the pending CTIs/CTRs of the erstwhile Divisions will be taken up by the respective same divisions either renamed or shifted.
- 6. This re-organization & re-jurisdiction will take effect from the 1st April, 2014, however to make these fully operational from 1st April, 2014, skeleton offices would opened with immediate effect.
