
In reference to the above noted subject this is to state that the Department of Minority Affairs & Madrasah Education, Government of West Bengal in collaboration with Ministry of Minority Affairs, Government of India started the Cyber Gram Scheme in the state of West Bengal. Under the same scheme all the students from class VI - X will be covered under 614 recognised Madrasahs and they will be provided computer training for thirty nine hours on basic computer course (BCC). Each student will appear for on line examination after completion of the training programme under NEILIT (formerly DOEACC society) and will be awarded certificates from NEILIT on successfully scoring the marks. On successful completion of course and securing certificates students will further get a coupon pack of thirty hours by which they can practice computer with internet access.

It is decided by Ministry of Minority Affairs, Government of India and subsequently by the Department of Minority Affairs & Madrasah Education, Government of West Bengal that CSC (Common Service's Centre) -E Governance Services will execute the scheme in the state. The people who run the 'Tathya Mitra Kendra' under Panchayat and Rural Development Department, Government of West Bengal i.e. village level entrepreneur (VLES) and also 'Sahaj-e-Village Ltd. have the responsibilities to execute the program at Madrasah level.

In view of the above, you are requested to cooperate with the above mentioned organisations in all respects (specially in terms of provision of class-room, electricity, equipments and security) and to help in execute the Cyber Gram Scheme in your Madrasah successfully.
