Director, PVD shall be the Competent Officer in respect of area under the jurisdiction of PVD, Kolkata and the District Magistrate shall be the Competent Officer in the respective district within the meaning & scope of West Bengal Right to Public Services Act, 2013.

This Notification shall come into effect from the date of its publication in the Official Gazette.
